A walkway from the current kitchen into the staffroom will likely be part of the plan. No district funding is available for the project, thus local contractors can be approached for bids. A.M volunteered to investigate whether any provincial grants may be available for the project.
- **d.) Hardship policy review** reported by J.D and S.B: A meeting has not been held yet, but Tracy Laschowski was approached by J.D to join the committee. The committee may consider approaching organizations such as the Catholic Women's League and the Knights of Columbus to purchase meals for student hardship cases.
